

# **Data Resources for Office of Inspector General**

The Pennsylvania Justice Network (JNET) provides authorized users with access to public safety and criminal justice information from numerous federal, state and local sources. Access to specific data sources is dependent upon your job function and permissions within JNET. The following applications are available to most office of inspector general officers.

#### **JNET Searches**

- Address Search The JNET Federated Address Search allows authorized users to simultaneously query address information from up to 11 distinct repositories
- Photo Search Returns up to five photographs from the both PennDOT Driver's Photo/History application and WebCPIN
- Warrant Search Returns active AOPC, Domestic Relations and PSP-CLEAN/NCIC warrants through one inquiry
- **Flexible Search** Searches a number of databases for corrections, court, sentencing, police and probation information

## **PennDOT Records**

- Driver's Photos/History Information (also available using JNET Federated Photo Search)
- Certified Driver's Records and Vehicle Registration (also available using the button links on the JNET home page) and Driver's License or Registration Pick-up (Lift Orders)

### **Justice Data**

- DCNR ATV/Snowmobile Inquiry: Registration, title, owner, and vehicle identification information on PA registered ATVs and snowmobiles
- Electronic Reporting Statistics –Adult Probation/parole and Prison reported population statistics
- JNET ORI look-up: Allows users to verify their JNET derivative ORI
- Master Charge Code (MCC): Charge code look-up & grading verification for criminal codes from multiple agencies
- PCCD Constable and Deputy Sheriff Query information on Sheriffs and Constables.
- Protection from Abuse Database (PFAD): PFA information from the PA Coalition Against Domestic Violence (PCADV)
- Search by SID: Searches 13 state and local number repositories based on the Offender State Identification Number (SID)
- SID/OTN Lookup: Cross reference associated State ID number (SID) and Offense Tracking Number (OTN)

#### **Court Information**

- Domestic Relations Warrants from the Pennsylvania Child Support Enforcement System (PASCES)
- AOPC Unified Justice Portal (UJS): Information and secure court documents from Common Pleas Courts, Magisterial District Courts and Philadelphia Municipal Courts.
- Pre-Sentence Investigation (PSI): Index of Court Ordered PSI, D&A, SOAB, Psychiatric and Psychological Assessments
- Law Enforcement Portal: Hearing schedules & case disposition look-up from the AOPC

## **JNET Notifications**

Real-time alerts to authorized users based upon criminal justice events, including arrest, wants/warrants, PennDOT change of address, AOPC sentencing, AOPC case bind over, AOPC dispositions, Parole Board violations, traffic and non-traffic citations and other events

# **Commonwealth Photo Imaging Network (WebCPIN)**

- Photograph repository including arrest photos, offender demographics and charges from 200+ Booking Centers, DOC, PBPP, County Jails and Probation Offices, and High Intensity Drug Trafficking Areas (also available using JNET Federated Photo Search)
- Includes the Interstate Photo Imaging Network (IPIN) with photographs from New York, Michigan and Florida

# JNET CLEAN/PSP CLEAN PortalXL

Access PSP-CLEAN, NCIC, III and NLETS information to determine criminal history, demographic and out of state information

- PA and out-of-state rap sheets
- Wanted persons
- Out-of-state motor vehicle/driver's query
- Stolen vehicles, articles, guns, boats, securities
- Gang association inquiry
- PA Sex Offender Registration tool
- Protection from Abuse information
